Brothers & Sisters,

I hope you had a happy holiday with family and friends. Construction season went late in 2019, given that we had a late start due to all of the rain last spring, so it was good that we were able to get in a few extra weeks of work before it got too cold.

If you have been laid off, or expect to be soon, please contact your local union office to be placed on to the out-of-work list.

In addition, with the construction season going later, we have had a later start to our training season. Please make sure you sign up for classes to update your skills prior to the start of the 2020 construction season.

2020 will be a huge year for the Wisconsin Laborers. Economic indicators and discussions with our signatory contractor partners signal that we will have a strong construction season, which will result in a lot of work for you and your brothers and sisters.

2020 will also have some significant contract negotiations, which include the following: 62-County Building; Asbestos; 66-County Sewer/Water; Local 113 Tri-County Building; Statewide Landscaping; Cable; and the WUCA Sewer/Water/Tunnel Agreement.

Please attend your local union meetings where you can provide input to your local union leadership for the upcoming contract negotiations and receive updates during negotiations.

Thank you to Local 330 for organizing the upcoming statewide benefits conference taking place on Saturday, March 7, 2020 in Kimberly, WI. This conference is open to ALL Wisconsin Laborers, and will be a great resource to learn more about your health and pension benefits with your fellow union brothers and sisters.

2020 will also be an important election year, where we will have important elections both in April and November. In April there will be an important Supreme Court election as well as local races, while in November there will be elections for President and state legislature. Not to mention in July, Milwaukee will be hosting the 2020 Democratic National Convention, which will result in significant construction work and volunteer opportunities.

It will be very important to have your voice be heard in the 2020 elections. In order to do so, please make sure you are registered to vote. You can check your voter registration by going to <https://myvote.wi.gov/en-us/MyVoterInfo>, and if you have questions on how to register to vote, please contact the District Council or your local union office.

On November 21, 2019, Governor Evers signed the Critical Infrastructure legislation (Assembly Bill 426/Senate Bill 386), now known as 2019 Wisconsin Act 33. This common sense legislation protects workers working on critical infrastructure projects throughout Wisconsin, and I would like to acknowledge and thank Governor Evers, legislators who supported the legislation, and you, the members who took the time to call and write your legislators asking them to support this legislation.

We are all members of our union, but being a union member also means that we are all organizers. Whether you are on your jobsite, at the Training Center, at a local union meeting, going through the grocery store checkout lane, or spending time with family and friends, we all play a part to help grow our union and make it stronger for our current members, but also for future members. Every day is an opportunity to organize.

Thank you for all that you do to make our union stronger, and I wish you a prosperous, successful, and safe 2020.



Training Center Report

Hello Fellow Laborers,

I hope everyone enjoyed the Holiday Season. As you are aware, it is the busy time at the Training Center.

Hopefully you have thought about your winter training schedule and have already registered. If you have not, there is still time to get into classes that you may need to get back to work. However, if you wait too long the classes may be full and you will then be put onto waiting lists.

If you have already registered for a class and you cannot make it, please contact the Training Center and let us know as soon as possible, so we can fill the class with fellow members from the waiting list. It is very important that you contact us as soon as possible, because this year we are planning to get a lot of our union brothers and sisters through the training they need and if we have empty spaces to fill we need to know as soon as possible.

The State of Wisconsin D.O.T. has changed the Flagging standard. You will now have to have a refresher course every 2 years. If you previously received a card from us, you will have to disregard the refresher date, because the State of Wisconsin rule replaces ours. If you took a class in 2019, you will need a refresher in 2021, but it may not be a bad idea to take a course this year to learn about the change that have been made. If you are interested in taking a Flagging course, as always you can fill out the registration form in the Trainer or go to our website to register at <https://training.wislaborers.org>.

Myself and the staff at the Wisconsin Laborers' Apprenticeship and Training Fund are looking forward to seeing you again. It is your Training Center so if you haven't been here to see the new addition we opened last February, here is your chance.

Have a great winter season and remember to be safe out there.

Got a Commercial Driver's License (CDL)?

The U.S. Department of Transportation's Federal Motor Carrier Safety Administration recently started a new program called the *Commercial Driver's License Drug and Alcohol Clearinghouse*.

This program requires all CDL drivers operating commercial motor vehicles to register in order to provide consent to current or prospective employers about any drug and alcohol program violations, and select a substance abuse professional if needed.

Local 113 participants can contact the Building Trades United Pension Fund at 262-784-7880.

Local 113 members who attend 8 meetings during the 2020 calendar year will receive a \$100 gift card to U.M.A. or Stars & Stripes for Local 113 apparel, or Red Wing Shoes or Boot Connection for footwear

All active participants and their spouses may participate in a Biometric Screening for Wellness Year 1 (July 1, 2019 - June 30, 2020). Arrive 15 minutes ahead of your scheduled screening to complete the health forms. You will receive a \$150 gift card or you may choose to have your deductible waived under the Health Plan.

Please note that if married, both the member and spouse must agree and sign to have their deductible waived rather than accept the gift card. Non-Medicare early-retirees are not eligible for deductible waiver but are eligible for the \$150 gift card.

Please remember if you are laid off, you NEED to be registered on our out-of-work list. Also when you return to work please call our office and let us know that you are back to work. Leave a message if it is after hours.

Attention Flaggers! Effective January 1, 2020 any flagger working on Wisconsin State Highways will need to be certified. Flaggers will need to show proof of certification if asked by WisDOT or other state inspectors. Failure to show proof may result in a shutdown of the operation. Get certified now while you are laid off!

Brothers and Sisters,

Happy New Year to you and your families.

All active members who have paid a full year's dues by March 31, 2020 will receive a \$38 check from Local 268 in April, 2020. This is only for active members and not retirees.

You have four different options that you can pay dues, including:

1. Mail check or money order payable to Local 268 to: 2233 Birch St., Eau Claire, WI 54703.
2. Pay at the Eau Claire office with cash, check, or money order.
3. Credit/debit card payments can only be done online at www.268members.org.
4. Another option for having dues paid automatically is to call your bank and set up a recurring payment with them mailing a check monthly. Retired members can opt to have their monthly dues deducted from their pension check and have the fund send a check monthly to the hall.

Please call to get on the out-of-work list when you are laid off, and to be taken off of the list when you return to work. When applying for unemployment benefits you need to call and get on the out-of-work list. You will be asked if you are a member of a trade union hiring hall in good standing and if you are on the out-of-work list to avoid doing a work search for a period of time. We have been receiving weekly checks on members and if you are not on the out-of-work list for the week they are inquiring about, they can ask when you last were on the list and go back and check prior unemployment claims.

If you are laid-off, please contact the WI Laborers' Training Center to get registered for classes. Your negotiated package provides for you to attend classes at no charge and if you are attending multiple-day classes, and you are more than 50-miles from the Training Center, you have the option of staying at a hotel they provide and have mileage reimbursed for your travel. Daily commuters will be paid \$20/day. Please go to <https://training.wislaborers.org/> for more information.

The Local 268 Executive Board voted to discontinue the informational meetings in Wausau due to the lack of attendance. Retiree Council meetings will still be held.

All members who attend one of the March 2020 meetings - general membership, informational, or retiree - will have a \$20 gift card mailed to them.

If you do have questions or are wanting to learn additional information about your benefits, you and your spouse should plan on attending the Laborers' Statewide Benefits Conference taking place on Saturday, March 7 from 2pm-5pm at the Liberty Hall in Kimberly, WI.

This conference is open to all active Laborers in Wisconsin, regardless of what local union they belong. It is also open to our contractors to help them understand the benefits the Wisconsin Laborers provide.

There is more information later on page 13 on how to sign up. Please take the time to learn how best to use our plan's benefits. I look forward to seeing you. And by the way, we will be providing food and drinks following the conference.

In Northeast WI, the Point Beach nuclear power plant will be having an outage for refueling this spring. B.H.I will need approximately 33 laborers to complete this project. We already have some members on this job site.

Greetings to my Local 464 brothers & sisters,
We have had a lot of work throughout the fall and winter months, which bodes well for a strong 2020 construction season.

KS Energy and Michels have completed distribution and fiber work on Hwy 19 in Dane County, while Larson Construction has poured the abutments on the new Hwy 19 bridge, with columns for the new deck starting soon, and James Peterson & Sons have installed the new storm sewer with this project expected to continue through summer.

We have construction beginning on the Sun Prairie, DeForest, Monona, and Milton school districts. Work on those projects will begin as early as March, 2020.

Work on the I-90 corridor will take place throughout the year.

A couple of major projects starting later on this summer include the Green County wind turbines project, liquified natural gas storage containers in Jefferson County, and the UW Hospital in Dane County.

Local 464 staff attended the Argyle School Board meeting in December 2019 where we had a good meeting with the goal of speaking with technical education classes later on this spring.

The Volunteer Organizing Committee (VOC) met on December 17, 2019. Discussion was had on the committee's role and ideas were shared. Starting next month, we will have a container at the back of the Local 464 hall for donations to homeless shelters and food pantries. Canned foods, non-perishable foods, and health & hygiene items are suggested.

Primary elections are scheduled for February 18, 2020 for county boards, school boards, municipal elections, and the Wisconsin Supreme Court.

Once the primary elections have concluded, we will be endorsing candidates for spring elections. The next VOC meeting will be on February 19, 2020 starting at 4:15pm. Any and all are welcome to attend.

Please make sure you are on the out-of-work list when you get laid off. We have been receiving phone calls from Unemployment checking on your status. Also, make sure you are taking classes at the Training Center when you are laid off.

Breakfast with Santa was a great success this year. We had 183 adults, and more importantly 162 very happy kids! Thanks to all who helped set up and attend.

Happy New Year from all of us here at Local 1091 in Duluth/Superior.

As we ring in another year and decade, your local is poised to become more active in the political process. We understand the importance of every election for federal, state, county, and municipal office. Your local school boards are important as well. With the competition for federal and state dollars going towards schools, infrastructure, and housing widening we need to be in constant touch with our elected officials to make sure we lobby to have that money awarded to our community.

Our Northern WI Building Trades Council and I worked together with the City of Superior to amend the city's Responsible Bidder Ordinance to further protect our work and our industry. We strengthened the apprenticeship language and made a change to have the ordinance called the Responsible Contractor Ordinance. This adds a layer of protection to ensure contractors possess all the federal, state and local requirements, including a city contractor's license, to perform work in the City of Superior.

Husky refinery is finally moving forward with the rebuild of the Superior Refinery that suffered an explosion in April of 2018. They are currently doing the work under the National Maintenance Agreement (NMA). Myself and others will be meeting with their construction team in the very near future to propose some additional compensation for shift work and travelers. Job timeline is roughly two years.

P&R Construction has started on a new 136 room apartment complex in Superior with retail outlets on the first floor. This development is located at the old Superior Central High school site on Belknap St in the middle of Superior. The work is all union and is using many of our Local 1091 members on the project.

We also have additional union projects taking place in Ashland, Bayfield and other parts of Douglas County.

I would like to remind all of our apprentices and journey workers that our training facilities offer scores of training opportunities or continuing refresher classes to make sure that we remain a step ahead and above of our non-union competitors. Train Up!

2020 will have us negotiating our Superior building agreement in April; having a local officers election in June; and our annual summer membership picnic in August. In addition to that are some save the date items to consider:

All monthly membership meetings are on the third Thursday of the month at the Duluth Labor Temple at 7pm. Bring a brother or sister to the meetings with you. In March, June, and Sept we will be having town hall style membership meetings to encourage our members to engage in activities through activism and volunteering for activities that are for the good of the union.

Your monthly membership dues will remain at \$38 for active members and \$8 for all active retirees.

In closing, on behalf of me and your executive board, have a safe and prosperous 2020 construction season, and Feel the Power, Be the Power and Use the Power. Congratulations on being loud and proud members of Laborers' Local 1091.

Health and Pension

Greetings everyone & Happy New Year! As we have mentioned prior, the Health Plan has made changes this year along with updating our website to make it easier for you to navigate. Again, a reminder to please visit the new website at: www.wilbenefits.com.

Once you access the website, you will see the most popular forms available under the PDF File to download. You can find instructions on how to access your hours and benefit information through the MemberXG portal (Link also provided on the right side), submit an updated Enrollment form with beneficiary information, or access the Pension application. You also have access to upload completed forms to us with the Upload Button. There is also access to all Health, Pension, HRA documents and a FAQ section with contact information for Service Providers that provide services for the Laborers Fund.

VISION - As I mentioned in the prior newsletter, the Fund now offers a Safety Glasses benefit for its active members! You should have received the notice recently which also explains "how" to use the EyeMed benefit to your advantage. If you do not recall receiving the notice, it is also under Health and then Notices on the website. The main point to remember is to always use your health benefit of \$250.00 before using your HRA card.

HRA Card Helpful Hits:

- When using your HRA card, supporting documentation (aka substantiation) must exactly match the amount of the debit card swipe and include the patient, provider, date of service, and service or item purchased
- Remember that unsubstantiated debit card expenses are subject to tax as income
- Substantiation can be mailed to the Fund office or emailed to wlhra@bpalja.com. Please be sure that items emailed are legible.
- Always use your health fund \$250 vision benefit before using your HRA card.

Yearly Reminder - Other insurance update information is requested for each family member on an annual basis and must be completed and returned to the Fund office before claims are released.

Disability - When filing disability claims, always include both sides of the disability form with the back side completed by your physician

Health Fund Claims Request for Information - Accident detail information is requested on any initial claim that may be an injury or have third party liability (such as workers comp, auto insurance, or homeowner's insurance). Again, we cannot release the claim(s) until this information is received.

Biometric Screening Events (Wellness) - If you have not signed up for a wellness event, please check the listings below to see if one is available in your area. It only takes 15 minutes for the screening! Remember to watch for the Orange Post Cards for additional dates this year.

Active Participants and their Spouses may participate in a Biometric Screening in Wellness Year 1 (July 1, 2019 - June 30, 2020). Please note that if married, both the member and spouse must agree and sign to have their deductible waived rather than accept the gift card. Non-Medicare Early Retirees are not eligible for deductible waiver but are eligible for the \$150 gift card.

Political & Legislative Action

Critical Infrastructure Legislation Becomes Law

On November 21, 2019 Governor Evers signed Assembly Bill 426/Senate Bill 386 into law, becoming 2019 Wisconsin Act 33. The bill passed both the Assembly and Senate on bipartisan voice votes. The Wisconsin Laborers' District Council was very involved in helping pass this important piece of legislation, by having members contact their legislators and testifying at the Assembly and Senate hearings.

This common sense bill simply expands upon current law where it was already illegal to trespass or cause damage to the property of an energy provider, and this bill expanded the definition of what types of infrastructure projects are protected. Many Wisconsin Laborers work on important infrastructure projects throughout Wisconsin, and guaranteeing members' safety and a safe jobsite is paramount.

In addition, this new law protects constitutional rights to assemble and protest, and provided significant labor protections, such as compliance monitoring for safety, wage and hour requirements, picketing, and union organizing.

Thank you to Governor Evers and members of the Wisconsin Legislature for supporting worker safety and passing this common-sense bill into law.

Voter Registration

Recently an Ozaukee County judge decided in a lawsuit to purge nearly 234,000 Wisconsin residents off of the voter registration rolls. While there are legal appeals being made to this ruling, it is important for you to check to verify that you and members of your family are still registered to vote. You can do this by visiting <https://myvote.wi.gov/en-us/MyVoterInfo>.

If you are not registered to vote, the Wisconsin Laborers' District Council and your local union can help you get registered before the 2020 Elections. Please contact either the District Council or your local union to learn more on how to register to vote.

2020 Democratic National Convention

Wisconsin will be the epicenter of the 2020 Elections, with Milwaukee hosting the 2020 Democratic National Convention from July 13-16, 2020. The host committee is looking for volunteers and there will be significant building and construction work at the various venues throughout Milwaukee.

Local 113 member and Milwaukee Area Labor Council President Pam Fendt is leading the labor volunteer program for the 2020 DNC. Union brothers and sisters and their family members interested in volunteering during the week of the convention should send their name, telephone number, and email address to malc@milwaukeeelabor.org. From there you will be contacted and directed how to get signed up with the host committee. Thousands of volunteers will be needed, and we know that labor always shows up to assist in this type of civic engagement activity. For more information call (414) 771-7070.
