



# District Council Business Manager's Report: John Schmitt



Brothers & Sisters,

As I write this, construction season continues to go strong, and I am hopeful that we have a mild fall to continue work on projects before winter arrives.

We are gearing up for another busy training season this upcoming winter. You recently should have received the 2019-2020 Training Schedule. Please do not hesitate to register for classes! You have the ability to use this resource to further your career and employment opportunities by expanding your skills and certifications, making you much more marketable to contractors. And remember, if you are laid off this winter, please make sure to contact your local union to be placed on your local's out-of-work list.

On July 22, 2019, we formally opened our expanded Training Center by holding a ribbon-cutting ceremony. Thank you to Governor Tony Evers, Lt. Governor Mandela Barnes, U.S. Representative Mark Pocan, and State Treasurer Sarah Godlewski for speaking at our dedication ceremony, and where we honored former Wisconsin Laborers' District Council President/Business Manager Mike Ryan. Mike's wife Julie, his sons, and many members of the Ryan family were also in attendance to help open our expanded Training Center.

Thank you to all members who took the time to send in comments to the Department of Labor on the proposed rule related to Industry Recognized Apprenticeship Programs (IRAPs). If these IRAPs are allowed in the construction industry, it would undermine our already existing and successful registered apprenticeship programs, and result in lower wages and benefits. We are still waiting to hear on the final DOL rule, but thanks to you and your fellow LiUNA brothers and sisters, over 88,000 comments were sent to the Department of Labor from LiUNA members saying "no" to IRAPs in the construction industry.

Finally, the recently enacted 2019-21 Wisconsin State Budget had some good news for Wisconsin Laborers, in particular by seeing significant increases in funding the state's transportation projects as well as building and construction projects through the state's capital budget. While we did not see every proposal that we supported in the budget get signed into law, this budget was a good down payment which will result in improvements to our state's infrastructure while providing a significant amount of work hours for members.

I'm a proud LiUNA member, and I look forward to waking up every day to work with members to improve our wages, benefits and working conditions. Our union is strong because of the strength and pride that we have combined as members of this great union.

Stay safe on the job, and I look forward to seeing you at the Training Center this winter.



Hello Brothers and Sisters!

I hope everyone has enjoyed a busy and productive work season. We are ramping up for the next training season, and I would like to remind you that if you are thinking of taking classes, please sign up early as they fill up fast.

You can register by filling out the form in the trainer that was sent to you, or by going online to our new website at <a href="https://training.wislaborers.org">https://training.wislaborers.org</a>.

If you are a current Flagging Certification holder, there are going to be changes to your refresher date of renewal. The Wisconsin Department of Transportation is now changing the length down to a two-year time frame as of 2020. So if you have a Flagging Certification through us, you will disregard the refresher date on it as we were previously going with a five-year cycle.

Please contact us if you are near the end of the two-year period, or over it, so that you are in compliance Also, you will be required to have your Flagging Certification card on you at all times, because the Department of Transportation will be doing spot checks of flaggers making sure that you are certified.

We have also added a new class for gas fusion welding this year. The class is called Pipe Fusion Prep, and is a two-day course covering 2-inch up to 6-inch of pipe fusion. This class is for preparation into the field of gas pipe fusion. We cannot offer a certification through the Training Center, but this is a great way to get hands-on experience in the gas pipe industry.

The staff at the Wisconsin Laborers' Training Center has added a few new instructors this year. Barry Downs will be instructing Basic Transit and Blueprint Reading. Bob Neis is our new Welding Instructor, and Gerald Heim will be instructing Scaffold and Mason Tending.

We are all looking forward to seeing you for training this year.

This has been a challenging year for us to fill jobs that require a multitude of skill sets. The Laborers are the most diverse trade hands down, and it is important to make sure that we continue to grow as members and a union to provide the required skills needed to perform the work for our employers.

Recently we placed a Laborer with a contractor. and before they could go to work, they needed to receive OSHA 30, First Aid/CPR, Forklift Certification, as well as their company training. This individual took the time to go through all of this training and is now working. This is just one example of how important it is to have the necessary training and certifications.

Work continues to be very strong in Northeast Wisconsin, and there are a few winter projects this year that will help, including the Point Beach Nuclear Power Plant that will be having an outage starting in the spring of 2020. Ramp up for that will start in January 2020 and go through March

Finally, Laborers Local 330 will be having a conference in March 2020 in Kimberly, WI for all active members (sorry retirees), and this conference will be open to all active members of our local unions, and not just for Local 330 members.

We will cover issues like health benefits, how to use them for you and your family, as well as prescription drug benefits, EyeMed, Anthem PPO, and covering topics around our pension.

Greetings to my Brothers & Sisters of Local 464.

Our local union is continuing to grow its membership, and in 2019 we have already signed 250 new members to our local union.

As membership continues to grow, we are seeing more new members attending our monthly membership meetings. This is very exciting as we continue to build our strength and power of our local union.

We are regularly receiving phone calls from our contractor partners asking for laborers who are experienced with flagging, bridge building, pipeline, and building construction. Please answer your phone when we call, and make sure you show up on the job site if you have accepted the job. We currently have approximately 50-60 members on the out-of-work list, and we strive daily to make sure we are filling jobs for our contractors.

Please make sure you are regularly updating your skills sheet, and with the winter and training season coming up, please make sure you take the time to sign up for classes to either learn new skills or to get recertified on your skills if needed.

Thank you to everyone in the local union for your commitment to fighting IRAPs in the construction industry. Throughout the country over 88,000 LiUNA members submitted comments out of the 325,000 from the different building trades unions.

We will continue to have legislative and political campaigns that we will be needing to engage in the future, and we will need our collective power as a union to support ourselves and our fellow brothers and sisters.

One project that we are excited about seeing Local 464 members start to work on is the SHINE Medical Technologies project in Janesville. This will house the production of medical isotopes used to diagnose and treat cancer and other diseases.

Our local had 22 apprentices graduate in 2019, and we also had 8 new Gold Card members this year. Congratulations to everyone for reaching these important milestones.

Finally, we are excited that a few of our members attended the NABTU 2019 Tradeswomen Build Nations Conference that took place in Minneapolis. Although this was the ninth Tradeswomen Build Nations conference, it was the first time that Local 464 participated. This conference had over 3,000 women members from the different building trades, and as more women join our union, this conference provided learning opportunities for our members to grow in their careers and in their involvement with their union.

Another spring and summer have come and gone and still a million things to do.

After a normal busy summer, we are looking for a very active winter with some large projects getting started late. The Husky Refinery just received their last regulatory permit, and plan to start work immediately with a 20 to 24 month complete rebuild of its Superior Refinery.

The Essentia Northland Vision facility will be a 3-year project with a \$1 billion price tag.

Superior will also be adding another 136-units of mixed-use housing and retail in downtown for \$23 million.

The Nemadji Trail Energy Center (NTEC) natural gas power plant is in the initial permitting process and has committed to a Project Labor Agreement with the Northern Wisconsin Building Trades. In addition, we have good work at the Ashland Memorial Medical Center in Ashland County and several other projects throughout Northwest Wisconsin.

As everyone knows, U.S. Representative Sean Duffy resigned his seat in September. It is still up in the air when the special election will be in 2020, but once that is set I encourage you to please make sure you get out to vote. Your vote is your voice, and elections matter!

Thank you to all that took the time to send a comment to the Department of Labor on the proposed Industry Recognized Apprenticeship Program rule. Our union, LIUNA, lead the construction industry in opposition to this proposed action to gut and cut our registered apprenticeship programs as we know them.

Local 1091 will host our annual food drive from November 21 through December 20. All cash and food donations will be distributed to the local food shelves in Superior and Duluth.

Just a few reminders moving into the winter. Plan ahead in bad weather, be safe, get flu shots for you and your family, attend your local union meetings to get all of the updates that affect your choice to be a union member, your rights as a union member, and your privilege of being a good union member and activist.

Here are a few reminders for upcoming union meetings, where we will be having our Thanksgiving Party at our November meeting, and our Christmas Party at our December meeting.

# Apprenticeship Coordinator

Brothers & Sisters.

As we wrap up a successful 2019 construction season, I wanted to provide you with some up-to-date apprenticeship data.

Over the course of 2019, we tested 850 candidates, started 250 new apprentices, and 63 have graduated so far.

We currently have 410 total apprentices, and have 540 candidates that have tested & are eligible to become apprentices. Unfortunately, we have canceled 122 apprentices this season for failure to remit OJT (on-the-job training) cards, attend training, poor attendance or poor performance at work, lack of communication, etc.

For our current apprentices, you are responsible for attending your training classes that I have scheduled for you as well as making sure that you are filling out and remitting your OJT (on-the-job training) cards every 2 weeks. To schedule your training go to http://training.wislaborers.org , call or text your selections. For first year apprentices' focus on your required training: OSHA 30, First aid/CPR, Flagging & an environmental course. A minimum of 144 hours of training is required per season. Near the end of your apprenticeship you are required to attend an 8 hour Transition to Trainer course, also provided at the training center.

Regardless if you are a current apprentice or journeyman, if there is another apprentice on your job site, talk to them and make sure that we are helping each other out to fulfill our requirements for our apprenticeship program.

Finally, as the Statewide Apprenticeship Coordinator, I see daily the value that our state registered apprenticeship program has to help our apprentices learn our craft and earn good wages and benefits as they start their career. I appreciate everyone who took the time to contact the Department of Labor to say "no" to having IRAPs be a part of the construction industry.

Hello Everyone – I hope you are enjoying the last of the warm weather. The Health Plan had a few changes this year along with updating our website to make it easier for you to access. Please visit the new website at: www.wilbenefits.com.

Once you access the website, you will see the most popular forms available under the PDF File to download. You can find instructions on how to access your hours and benefit information through the MemberXG portal (Link also provided on the right side), submit an updated Enrollment form with beneficiary information, or access the Pension application. You also have access to upload completed forms to us with the Upload Button. There is also access to all Health, Pension, HRA documents and a FAQ section with contact information for Service Providers that provide services for the Laborers Fund.

<u>Vision</u> - The Fund now offers a benefit for Safety Glasses. Please watch your mailbox for more information. For benefits at an EyeMed provider, please be sure to present your EyeMed ID card to your vision provider. If you do not have an EyeMed ID card, simply tell the provider you have the benefit and they will use your name to access the benefits. Your bill should then come to us for reimbursement up to the annual maximum of \$250. If you go to a vision provider that is not a member of EyeMed, please file your claim first for limited EyeMed discounts, using the form available on the BPA website (login information above). Then send the bill and the EyeMed EOB to the health fund for reimbursement up to the annual maximum of \$250. As a reminder, do not use your HRA card for vision benefits until after the claim has been paid by the health fund benefit of \$250.

<u>Self-Payment Options</u> – There is now an option to pay your Self-Payment online with a credit card. Once you log into the website, <u>www.wilbenefits.com</u>, you put in the member's name and then click Pay Now. You have the option to use any card or login with PayPal. You do NOT need a PayPal account to pay your self-payment.

<u>LiveHealthOnline</u> – Remember you have access to an online physician 24 hours a day, seven days a week! There is NO cost to you if you utilize this service. The physicians can treat and prescribe medications for common illnesses as well as some behavioral health issues. Log onto livehealthonline.com and have your Anthem ID card available to complete the form. It takes less than 5 minutes to complete.

Biometric Screening Events (Wellness) - Active Participants and their Spouses may participate in a Biometric Screening in Wellness Year 1 (July 1, 2019 - June 30, 2020). Arrive 15 minutes ahead of your scheduled screening to complete the health forms. You will be handed a gift card of \$150 or you may choose to have your deductible waived under the Health Plan. Please note that if married, both the member and spouse must agree and sign to have their deductible waived rather than accept the gift card. Non-Medicare Early Retirees are not eligible for deductible waiver but are eligible for the \$150 gift card.

# **Legislative Report**

2019-21 Wisconsin State Budget
On July 3, 2019, Governor Evers
issued his partial vetoes, which
completed the passage of the 2019
Wisconsin state budget. The final
budget that was enacted as state law
was significantly different than the
budget proposal that the
Governor introduced in February
2019, making many significant
changes by the Republican-led State
Legislature.

The Wisconsin Laborers' District Council closely monitored and participated in many issues and budget items that were debated during the biennial state budget process. The following is a summary of issues that impact you and your fellow union brothers and sisters.

Transportation Funding – While Governor Evers' proposed budget called for an eight-cent increase on the state's gasoline tax that would have been offset by a reduction in the minimum mark up law for gasoline, these provisions were eliminated by the Republican-led legislature. However, due to different fee increases including vehicle title and registration there is an increase in \$465 million in transportation funds.

This is the first time in a decade Wisconsin has dedicated new funding to our transportation projects, which will result in significant work for Wisconsin Laborers.



Capital Budget – Governor Evers originally requested a \$2.5 billion capital budget to pay for building projects throughout the state. While this was eventually reduced to \$1.9 billion, this was still a significant increase over any capital budget that occurred during the previous Walker Administration, and again we are excited that this will add work for our members in the coming years.

Right-to-Work/Prevailing Wage/Project Labor Agreements - Despite some significant good that came out of the Wisconsin budget, there were some things that did not change. While Governor Evers' original budget proposal included repealing the state's so-called Right-to-Work law, and reinstated the state's prevailing wage laws and ability to implement project labor agreements on public projects, the Republican-led legislature stripped these provisions out of the budget on party-line votes. Moving forward, we will continue to advocate for these pro-worker policies to be re-enacted into state law.

# **Legislative Report**

### <u>Critical Infrastructure Legislation</u>

The Wisconsin Laborers' District Council supports AB426/SB386. This important legislation would expand upon existing state law, where it is already illegal to trespass or cause damage to the property of an energy provider. This legislation expands the law to additional pieces of infrastructure, such as water, as well as infrastructure that is owned, leased, or operated by energy providers.

Many Wisconsin Laborers work on important infrastructure projects throughout Wisconsin and some even travel around the United States working on these projects. This is dangerous work and depends on a skilled, safe, and productive workforce. As a union, we strive to ensure that our members have a safe jobsite when they go to work. Unfortunately, there have been occurrences over the last few years where our members have had their safety physically threatened by people opposing infrastructure projects.

In addition, this bill explicitly protects people's constitutional right to assemble to protest, as well as provides significant labor protections.

On September 26, 2019, Kent Miller, Assistant Business Manager of the Wisconsin Laborers' District Council and Pam Fendt, member of Laborers' Local 113 and President of the Milwaukee Area Labor Council testified our union's support to the Assembly Energy & Utilities Committee, and we will continue to monitor and express our union's support as this bill works through the legislative process.

### **IRAPs**

Thank you to all active members, retirees, and family members who took the time to submit a comment to the U.S. Department of Labor opposing Industry Recognized Apprenticeship Programs (IRAPs) in the construction industry.

While the proposed DOL rule exempted IRAPs from the construction industry, the Wisconsin Laborers and our LiUNA brothers and sisters throughout the country made their voices heard to the DOL to not include IRAPs in the final rule. Over 88,000 LiUNA members submitted comments out of the 325,000 total comments submitted by building trades members throughout the country.

### 2020 Elections

The 2020 elections are on the horizon, and while the 2020 Presidential election will receive the majority of the headlines, the Wisconsin Laborers' District Council will also be planning to meet with candidates for Congress, State Legislature, State Supreme

Court, and local elected offices to discuss our issues and where the candidates stand on them. We will then make endorsement recommendations to support candidates who support the Wisconsin Laborers and working people.


